NOTE:-

1. Act Apprenticeship/ITI in any trade is the only qualification and no other qualification including Diploma in Engineering should be accepted as an alternative qualification on the ground of being a higher qualification in the same line of training.
2. No age relaxation (upper or lower) shall be permissible for recruitment through Open Advertisement.
3. No relaxation in minimum educational qualification shall be permissible in the case of recruitment through open advertisement.
4. No post is reserved for SC, ST, OBC & EWS. However the candidates claiming to belong to SC/ST/OBC & EWS communities are required to enclose photocopy of **self attested caste certificate** issued by the competent authority.

All the championships mentioned above should be conducted under the aegis of recognized International/National/State sports Federations and recognized by the Railway Sports Promotions Board.

Note:- For recruitment in Pay Matrix Level-1 & 2 (7th CPC), achievements should be in the current and/or immediate preceding 02 years i.e. from 01.04.2023 and the sportspersons should be an active player. For validity of sports achievement, concluding day of the championship/event shall be taken into account.

IV (A) Application Fee:-

(i)	For all candidates except those mentioned in sub-Para (ii) below	Rs. 500/- (Rs. Five hundred only) Application fee of Rs. 400/- will be refunded after deducting bank charges to these categories of candidates only when they actually appear in the Trial.
(ii)	For candidates belonging to SC/ST/Ex-Servicemen/Persons with Disability/Women Minorities* and Economic Backward Class**	Rs. 200/- (Rs. Two Hundred Fifty Only) Application fee will be refunded after deducting bank charges to these categories of candidate only when they actually appear in the Trial.

Note:- Candidates are advised to deposit the requisite fees for application in favour of PFA/RCF/KXH's Online Account No: 65035290377, IFSC Code SBIN0050540 of State Bank of India before the closing date and copy of the fees receipt should be attached with application otherwise application will be rejected. Cheque, Draft & Postal Order will not be accepted.

(b) FEE EXEMPTION

- A) For claiming exemption/refund from the application fee, Minority candidates should submit 'self declaration' as mentioned in Format 'A' at the time of Document Verification. *Minorities mean Muslims, Christians, Sikhs, Buddhists and Zoroastrians (Parsis). Such candidates claiming exemption of application fee will be required to furnish minority Community declaration affidavit on non-judicial stamp paper that he/she belongs to any of the above minority community. If the affidavit is not produced during document verification, the candidature will be rejected.
- B) **Economically Backward Classes (EBC) will mean the candidates whose Family Income is Less than Rs. 50,000/- per annum.



The following authorities are authorized to issue income certificate for the purpose of identifying economically backward classes (EBC):

- (i) District Magistrate or any other revenue officer up to the level of Tehsildar.
- (ii) Sitting Member of Parliament of Lok Sabha for persons of their own constituency.
- (iii) BPL card or any other certificate issued by the Central Government under a recognized poverty alleviation programme or Izzat MST issued by Railways.
- (iv) Union Minister may also recommend for any persons from in the country.
- (v) Sitting Members of parliament of Rajya Sabha for persons of the district in which these MPs normally reside.

The income certificate issued as mentioned below by the authorities mentioned above have to be produced at the time of Document Verification.

All eligible candidates will be called for trial and after trail, only the FIT candidates (securing 25 or more, out of 40 marks of Game Skill, Physical fitness and coach's observation during Trial) shall be assessed for next stage of recruitment candidates declared NOT FIT by the Trial committee will not be assessed further by the Recruitment committee.



VI) How to apply:-


1. Applications in prescribed format on Annexure-A size good quality paper may be downloaded from the website www.rcf.indianrailways.gov.in may be typed neat & clean one side.
2. Application is to be filled up by the candidates himself in his/her own handwriting and must signed affixing a passport size photograph with clear face on the space provided and one should be attached duly attested.
3. Applicant will attach the attested photocopies of educational and sports achievements certificates on proper format.
4. Candidates to ensure their eligibility before applying:- The candidates should ensure that they fulfill all eligibility conditions prescribed for the post. Eligibility of the candidates for the post notified in this notification would be decided on the basis of the information furnished by them. If at any stage of recruitment or thereafter, it is found that ,any information furnished by the candidate in his/her application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria for the post(s), his/her candidature will be cancelled forthwith.
5. Railway administration will not be responsible for late delivery and postal delay.
6. The last date & time for receipt of application in the office of the General Manager (Personnel).
7. Candidate super scribe clearly on the Envelope "RECRUITMENT AGAINST SPORTS QUOTA FOR THE YEAR 2025-2026 IN LEVEL-01 OR LEVEL-02.
8. The application can be sent by any post.
9. Railway Administration reserve the right to cancel the Recruitment process in exceptional circumstances.
10. Under no circumstances applications received after the closing date & time will be entertained.
11. The sportspersons recruited against Sports Quota through Open advertisement will have to fill and sign the service bond for period of five years.
12. The sportsperson recruited against sports quota through Open advertisement will undergo probation periods of two years after completion of training, if any.
13. The sportspersons appointed through open advertisement quota, shall fulfill the minimum medical norms for the post, for which they will be appointed.
14. Sports persons recruitment against sports quota through open advertisement shall be terminated from service, if the information and documents furnished by them for recruitment, are found incorrect/false at any stage, observing requisite procedure forp such terminations.
15. Applicant should mention his/her playing position along with the game in the application form.
16. Candidates those who are already in service of Pus/Govt. Organizations and are eligible for the above should produce "No Objection Certificate" for the same from their employer at the time of applying /trails.



17. Candidate's admission in stages of the recruitment will be purely provisional subject to satisfying the prescribed eligibility conditions. Mere issued of call letters to the candidate will not imply that his/her candidatures have been finally cleared.
18. Sportspersons having sports norms for higher level and apply against the vacancies for the lower level, can be considered. However, he/she will not claim for higher level after joining the Railways on the basis of Sports achievements prior to joining Railways.
19. The decision of selection committee/administration in all matters relating to eligibility, acceptance or rejection of application etc. will be final and binding on the candidates and no inquiry or correspondence will be entertained in this connection.
20. Production of original documents of Date of Birth, Educational Qualification, Sports achievements and SC/ST/OBC/EWS etc on the day of Trail and interview is mandatory without which they will not be allowed to appear in the Trail/Interview. Certificates in languages other than English or Hindi should be accomplished by an attested translation in English/Hindi. No TA/DA/Accommodation will be given for appearing in the selection trails/interview. Applicants will have to bring their own kit. They may also be required to stay during the selection trials for 2-3 days, for which they have to make their own arrangements. The railway administration has all rights reserved to fix any date/place or postpone trails/interview or cancel due to unforeseen causes against which no claim will be accepted.
